1	The total number of section of the school shall be restricted to 16 and further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per Affiliation Bye Laws and subject to the availability of room size of greater than 500 sq ft.
2	As per data uploaded by the school, there are 16 classrooms as per prescribed dimension and the school is running 16 sections upto class 8th. There is no extra classrooms of prescribed dimension for running classes IX & X. Now as requested by the school vide email dated 25/06/2023 (4:29:36 pm), the type of application has been changed from secondary level to Middle Class Syllabus. The school shall submit a revised composite building safety certificate including all the blocks in the school campus ,in the prescribed format within 3 months and submit compliance on SARAS.
5	The school has submitted a fit for occupancy certificate instead of a fire safety certificate from the directorate of Fire services, Govt of Andhra Pradesh.The school shall submit the fire safety certificate within 3 months and submit compliance on SARAS.
6	The school shall conduct training of its teachers with CoE Vijaywada within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.
